- A copy of your 2nd installment tax bill with the Homeowner's Exemption applied or Certificate of Error
- A printout from www.cookcountytreasurer.com showing that all taxes on the property have been paid
- A copy of your State of Illinois issued identification (driver's license or State ID) showing the property address.
- A recent utility bill for the property.

Due to COVID-19, the Village will not make copies of any of the above items.

Grant Applications cannot be submitted until October 1, 2021

Grant applications must be received or postmarked by February 1, 2022
